program; and

WHEREAS: Amateur radio clubs throughout Minnesota provide courses of instruction and

assistance to elementary and high school students about amateur radio, enhancing students' interest in science, geography, and physics, and provide an

opportunity for students to become licensed amateur radio operators.

NOW, THEREFORE, I, MARK DAYTON, Governor of Minnesota, do hereby proclaim June 25 and 26, 2011 as:

AMATEUR RADIO OPERATOR RECOGNITION DAYS

in the State of Minnesota.


